Dear Sir,

In terms of Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Regulations') and other applicable provisions of the Regulations, we have to inform you that the Appeal made by the Company before the Appellate Bench of Hon'ble Small Causes Court, Mumbai ['the Court'] challenging an eviction decree & judgment of the Trial Court to vacate the premises being its Corporate Office at Gate No. 10, 1st Floor, Brabourne Stadium, 87 Veer Nariman Road, Mumbai 400 020, has been dismissed with costs on 18<sup>th</sup> June, 2025 ('the Judgment'). The Judgment containing the details is awaited.

The Company has on 19<sup>th</sup> June, 2025 obtained a stay on the execution of the decree.

The brief details of the matter are as follows:

ii) Court/Tribunal/Agency where litigation is filed	The Court of Small Causes, Mumbai
iii) Brief details of dispute/litigation	<p>In the year 1996 an eviction suit was filed against the Company by The Cricket Club of India Ltd. (Landlord) before Hon'ble Small Causes Court, Mumbai, thereby praying for eviction of the Company from the premises as mentioned hereinabove and for mesne profits.</p> <p>The Company lost the said suit and had challenged the order and eviction decree of the Trial Court via appeal before Appellate Bench of the Court.</p>

	As stated herein above the Appeal has been dismissed with costs and the Company is awaiting the judgement copy. Upon receipt of the same, the further course of action will be taken accordingly.
