Sub: Scrutinizer's Report on Postal Ballot conducted through e-voting and physical ballot forms pursuant to provisions of Section 110 of the Companies Act, 2013 ("the Act") read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules

I, Shailesh Kachalia, Practising Company Secretary, was appointed as the Scrutinizer by the Board of Directors of Hardcastle & Waud Mfg. Co. Ltd. ("the Company") vide its resolution dated 25<sup>th</sup> July 2014, pursuant to Section 110 of the Act read with the Rules made thereunder, to scrutinize the remote e-voting process and postal ballot.

The Notice dated 4th September 2017, for transacting the special business by passing special resolutions through Postal Ballot along with Statement setting out its material facts under Section 102 of the Act was sent to its Shareholders by the Company.

The Company has availed the remote e-voting facility offered by National Securities Depository Limited ("NSDL") for conducting remote e-voting by shareholders of the Company. The Company had also provided facility of voting by physical ballot papers to its shareholders.

The voting period for remote e-voting commenced on Wednesday, September 6, 2017 at 09.00 a.m. and ended on Thursday, October 5, 2017 at 5.00 p.m. The NSDL remote e-voting platform was thereafter blocked and the votes cast under remote e-voting facility were then unblocked in the presence of two witnesses who were not in the employment of the Company. No votes were cast through Physical Ballot forms, upto Thursday, October 5, 2017. The voting rights of holders of 9650 unclaimed equity shares held in demat suspense account are frozen

Based on the data downloaded from the NSDL remote e-voting system, I have scrutinized and reviewed the voting through remote e-voting.
